**DIRECTIONS FOR USE:**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling

When used in hospitals, patients should be removed prior to treatment. Ventilate for two hours after treatment. Do not return patients to room until after ventilation

**IN MISTING EQUIPMENT:** Use spraying device similar to a Microsol machine or cold aerosol generators such as MICRO-GEN and LECO

**IN PRESSURIZED TANK SPRAYERS OR MACHINE TRIGGER SPRAYERS:** To kill the listed insects, use a rate of 1 gallon per 1000 square feet of surface area.

**TO KILL COCKROACHES, ANTS, CRICKETS, SPIDERS, CENTIPEDES AND FIREBRATS:** Contact as many insects as possible with the spray in addition to thorough spraying of all parts of the room suspected of harbouring these pests. Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators and wherever these pests are suspected of hiding. To kill ants, treat doors, around window frames, ant trails and other areas of entry. Repeat as necessary.

**TO KILL CARPET BEETLES AND FLEAS:** Directly spray as many insects as possible. Spray both interior and exterior of upholstered furniture. Both top and bottom of rugs and carpets should be sprayed thoroughly. Also treat shelves, closets, areas under furniture and wherever these insects are seen or suspected. Repeat as necessary.

**Hazards to Humans and Domestic Animals**

**CAUTION:** Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes. In case of contact, immediately flush eyes or skin with plenty of water. Obtain medical attention if irritation persists.
