Fill the room with mist, then leave the treated area. Keep the room closed for at least 15 minutes. Ventilate the room when treatment is completed

Weeps: Application should be made in late evening when insects are at rest Spray liberally into hiding and breeding places, contacting as many insects as possible. Repeat as necessary.

Cockroaches, Earwigs, Sowbugs, Spiders: Spray thoroughly into hiding places such as cracks, crevices, moist areas, openings around pipes and sinks, under refrigerators, baseboards and storage areas. Spray directly on insects when possible. Repeat as necessary.

Ante: Spray trails, nests and points of entry. Spray on ants where possible. Repeat as necessary
