DIRECTION FOR USE:

SOIL INFESTING INSECTS ON LAWNS: White Grubs, Wirewarms, White Fringe Beetle Larve—2½ to 5 pints 74% Chlordane with sufficient water for acre coverage. The amount depends on the type of soil. For Japanese Beetle larve use 10 pints per acre. mediately wash spray into ground. For wirewarms wash spray no ore than % inches in ground.

NOTE: Keep children and pats off treated area until material is watered in soil and grass is thoroughly dry.

HOUSEHOLD INSECTS: Roaches, Silverfish, firebrats, household spiders, ants—use at a dilution of 1 pint 74% Chlordane concentrate with 6 gals. water. Thoroughly spray cracks, hiding places inhabited by these insects with a coarse, wet spray. Repeat applications when necessary.

ANTS: (Indoor) Use same dilution as above and same to prough application. Apply to ant trails and areas where these pests enter premises such as window sills and door frames.

(Outdoor) Same dilution can be applied to anthills on an acre basis: 1-11/2 pints of concentrate plus sufficient water for coverage. This will also control chiggers. Do not apply to feed crops.

TERMITES: Mix 1 to 2 qts. Redwood 74% Chlordane with 50 gaillons water. Apply at a rate of 1 gai. of diluted spray per 1 linear foot to a trench dug next to the foundation 1 to 2 ft. deep and 8 to 12 in. wide. Dig trench 30 in. deep for building with deep foundation. Do not dig trench below level of the footing. Apply to infested wooden structures. Inspect area yearly to determine assible reinfestation.

Do not reuse empty drum. Return to drum reconditioner or destroy by perforating or crushing and burying in a safe place.

Do not use in commercial food preparation areas or in edible products areas of processing plants.
