

DIRECTIONS FOR USE:

INDOORS- FOR HOUSEFLIES, MOSQUITOS AND GNATS: Apply as a space spray. Mix well before using. Fill spray tank with undiluted Redwood Flea Kill 0.25% insecticide spray formulation. Adjust pressure and nozzle to deliver a fine mist spray. Close all doors and windows. Point nozzle upward, direct the spray mist to all parts of the room especially windows and other light sources which attract these insects. Keep the spray nozzle at all times at least four feet from fabrics to avoid wetting or staining. Fill the room with mist at the dosage rate of one fluid ounce per 1,000 cu. ft. of space. Then leave the treated area. Keep the room closed for at least 15 minutes. Ventilate the room when treatment is completed and before re-entry.

INDOORS—FOR CRAWLING INSECTS: Apply as a contact spray. Mix well before using. Fill spray tank with undiluted REDWOOD FLEA KILL 0.25% insecticide spray formulation. Keep spray nozzle about 8 to 12 inches from surface to be treated. Adjust pressure and nozzle to deliver a coarse spray with particle size larger than that of the average aerosol. When possible, spray directly on roaches, earwigs, grain mites, sowbugs, spiders and centipedes to reduce infestations. Spray thoroughly into hiding places, cracks, crevices, moist areas, openings around pipes and sinks, under refrigerators, baseboards and storage areas. Apply spray until area is moist, but not to the point of run-off. Spray directly on insects when possible. For fleas indoors, apply to infested areas of floors and floor coverings.

ANTS: Spray trails, nests and points of entry. Spray on Ants when possible. Repeat as necessary.

FLEAS: Protect dogs and cats from fleas by spraying their resting areas. Hold spray nozzle about 18 inches from area to be treated. Apply spray at the rate of two seconds per linear foot. Direct spray on resting areas and floor surfaces of dog houses. Repeat as necessary.

Also treat dogs and cats with a registered product before they re-enter the area just treated with this product.

OUTDOORS TO CONTROL FOLLOWING NUISANCE PESTS: ANTS, FLEAS, SPIDERS, WASPS. Apply as a coarse contact spray. Spray directly on insects.

ANTS: Spray trails, nests and points of entry. Spray on ants where possible. Repeat as necessary.

FLEAS: Same as directed for indoor use

SPIDERS: Direct short bursts of spray on spiders and repeat as necessary.

WASPS: Application should be made in late evenings when insects are at rest. Spray liberally into hiding and breeding places contacting as many insects as possible. Repeat as necessary.

ENVIRONMENTAL CAUTIONS:

This product is toxic to fish and birds. Keep out of lakes, streams, or ponds. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from treated areas. Contaminate water by cleaning of equipment or disposal of waste. Apply this product in accordance with this label.
