

**DIRECTIONS FOR USE:**

**ROACHES, WATERBUGS, SILVERFISH, SPIDERS, CENTIPEDES, CRICKETS:** Adjust sprayer to produce large wetting type spray particles. Direct spray to contact these insects in cracks and crevices, in floors; baseboards, around pipes, behind cabinets and other harborages. Spray these areas until thoroughly wet. Repeat as necessary.

**ANTS:** Spray ant trails and openings through which ants enter the house. Repeat as necessary.

**WASPS:** Application should be made in late evening when insects are at rest. Spray liberally into hiding and breeding places. Repeat as necessary.

Leaves an invisible film, effective for several weeks, that kills Roaches, Waterbugs, Silverfish, Spiders, Centipedes, Ants and Wasps which come in contact with it.

This product is toxic to fish, birds and other wildlife. Birds feeding on treated areas may be killed. Keep out of lakes, streams or ponds. Do not apply where runoff is likely to occur. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.

Do not store near open flame. Do not open, pour, or spill near an open flame. Extinguish open flames before spraying.

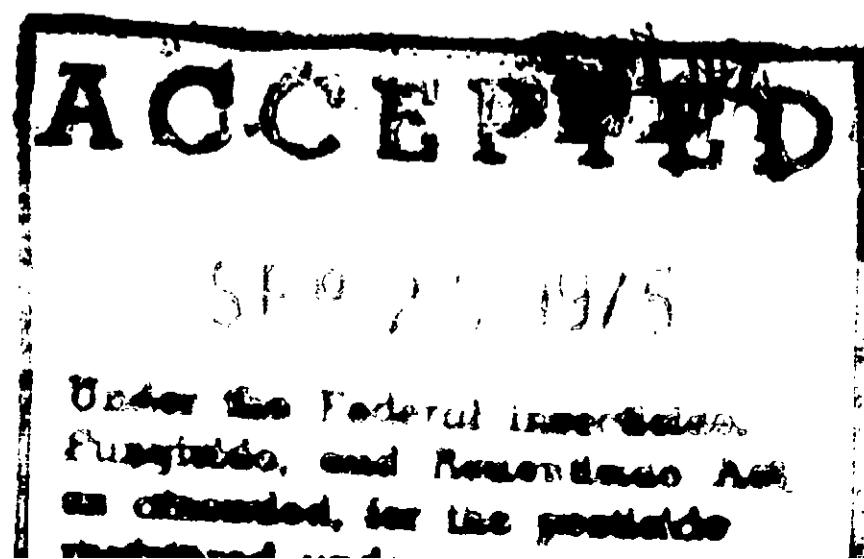
