

DIRECTIONS

PREPARATION OF THE BUILDING PRIOR TO FOGGING: (1) Close all doors, windows, and ventilators. (2) Turn off pilot lights and prevent persons and animals from entering the area. (3) Room temperature should read over 70°F. for best insect kill.

Use 1 to 2 ounces of Carmel Formula F-4 per 2,000 cubic feet of room space.

This is essential to give adequate distribution in large rooms. Walk backward down the center aisle of the room swaying the Insecticidal Fog Applicator back and forth to blanket the entire cubical contents of the room. Length of exposure time is 1 hour with windows and doors closed. After this exposure time, the room should be ventilated - at least 1 hour before re-entering.

CAUTION

Do not contaminate food, feed, milk, milk handling equipment or drinking water.

Avoid pouring, spraying or storing near fire or flame. Harmful if swallowed.

Keep away from children. Avoid breathing spray mist. Do not use in poultry houses.
