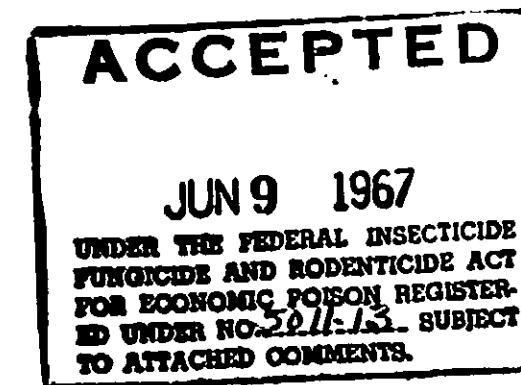


Carmel Residual Spray Concentrate No. 2

ACTIVE INGREDIENTS

Methoxychlor Technical*	21.0%
Gamma isomer of benzene hexachloride (from Lindane)	3.5%
Aromatic petroleum derivative solvent	65.5%

INERT INGREDIENTS

10.0%

Total 100.0%

*21% methoxychlor, technical is equivalent to 18.4% to 2,2-bis (p-methoxyphenyl)-1,1,1-trichloroethane and 2.52% other isomers and reaction products.

DIRECTIONS

An Emulsifiable Residual Insecticide Concentrate containing 21% Methoxychlor and 3.5% Lindane. Must be diluted with water or oil before using. To be brushed or sprayed on surface locations such as floors, walls, window sills and screens to leave a residue after evaporation which acts as a nerve poison to kill flying and crawling insects.

Dilute at rate of 1 gallon CARMEL RESIDUAL SPRAY CONCENTRATE NO. 2 with 6 gallons of water or insecticide base oil.

Application of diluted CARMEL RESIDUAL SPRAY CONCENTRATE NO. 2 should be made at rate of 1 gallon per 500 square feet of unpainted wooden surfaces, concrete, brick and masonry. For treating painting wood, metal and glass, use at rate of 1 gallon per 1,000 square feet of surface. Use as a coarse wet spray to treat all surfaces, cracks and crevices of infested areas until wet.

BAKERIES, FLOUR MILLS, AND OTHER FOOD PROCESSING PLANTS:

For killing exposed stages of Roaches, Waterbugs, Silverfish, Flour and Grain Beetles, and Weevils, apply as a coarse wet spray to treat surfaces, cracks and crevices of infested areas until wet. Spray only on floors and other hiding places to kill crawling insects. In storage warehouses, spray the floors and walls whenever stock is moved. Repeat treatments as often as necessary. To kill Houseflies, Gnats and Mosquitoes, thoroughly wet all surfaces where these insects alight or congregate.

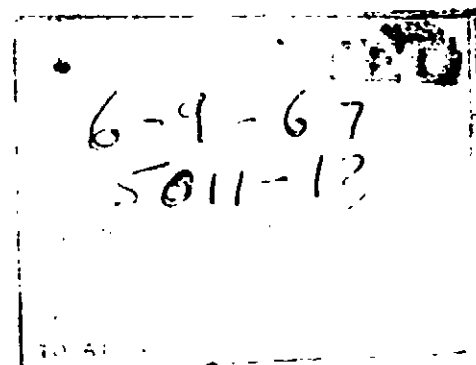
