
DIRECTIONS

Carmel Larvicide contains Fenthion for spraying on water to kill aquatic mosquito larvae and floating eggs. Where ditching stagnant streams, draining backwater pools and filling in of abandoned gravel pits and dumps are not feasible, Carmel Larvicide is recommended.

ANOPHELINE AND CULICININE MOSQUITOES: Apply Carmel Larvicide with hydraulic power sprayer, compressed air sprayers, or sprinkling can, on mosquito breeding waters, including ponds, edges of lakes, stagnant pools, drainage ditches, storm sewers and the like. Desirable rate of application should be 14 gallon per acre of water surface.

This product is extremely hazardous to shrimp and other shellfish.

Do not use in tidal areas such as marsh lands, and estuaries.
