DIRECTIONS

TO USE AS A FOGGING INSECTICIDE

FOGGING APPLICATION INDOORS: In food processing plants, dairies, restaurants, industrial plants, granaries, theaters, warehouses, horse stables, kennels and barns for Flies, Mosquitoes, Wasps, Gnats and other small flying insects. After closing off all air currents, direct fog upward at walls and ceilings so that as many insect as possible can be contacted with a direct vapor or fog. Application is to be made with the CCC-167 Automatic Electric Fogger. Use one ounce of Carmel Formula AE-5 per 3,000 cubic feet of space. Doors and windows should be closed for at least 1 hour after fogging; then sweep up and destroy all dead and dying insects. Repeat when necessary. For exposed stages of Beaches, Crickets, Ants and similar crawling insects, first direct the spray nozzle close into cracks and crevices and to wet the surfaces; then use one ounce of Carmel Formula AE-5 per 1,000 cubic feet of space. Doors and windows should be closed for at least 1 hour after fogging; then sweep up and destroy all dead and dying insects. Repeat when necessary.

FOGGING APPLICATION OUTDOOR: Adult Mosquitoes, Flies and Gnats - Envelop total area to be treated with a fog. Pay particular attention to all zones of stagnation, ponds, rubbish piles, etc.

CAUTION

Harmful if swallowed. Keep away from children. Avoid breathing fog or spray mist. Remove pets, birds and fish bowls before applying. Do not contaminate food, feed, milk, milk handling equipment or drinking water. Avoid pouring, spraying, or storing near fire or flame; turn off all pilot lights. Do not

in food processing plants only when plant is not in operation. Foods should be
removed or covered, also food processing surfaces, during treatment.
