DIRECTIONS

This insecticide should not be diluted, but used "as is", in Insecticide Fogging Applicators.

MOSQUITOES AND GNATS: Envelop total area to be treated with a fog. Pay particular attention to all zones of stagnation, ponds, etc. Apply one gallon of Carmel MU-21 per acre (equivalent to approximately 0.08 lbs. actual Fenthion per acre) of Marsh, swamp, pasture, woodland, grass and foliage.

Flies: Envelope in a fine fog. Use fog in killing flies for many critical areas, such as rubbish piles and recreation grounds. Do not use in any barns. Do not use this product on any livestock.

Fogging for mosquito control is only one phase of effective mosquito control. MU-20 Mosquito Larvicide applications should be made where standing water cannot be drained. Most successful fogging is done after sunset, in the evening, when the earth drops to a temperature less than that of the overlying air. This results in the fog hugging the ground and drifting widely through grass and foliage. Use prevailing wind direction to plan fogging operation. Start at farthest point down-wind and work into the wind at cross angles. If wind becomes strong enough to rapidly dissipate fog, discontinue operation until wind settles.

CAUTION
