
### DIRECTIONS

This concentrate should be diluted at a rate of 7 gallons of concentrate in 93 gallons of No. 2 Fuel Oil, or special "Fogging Oil" for use in Dyna-Fog Insecticide Applicators, or any thermal aerosol fogging machines.

Mosquitoes and Gnats: Envelop total area to be treated with a fog. Apply one gailon of diluted Carmel Formula MU-12 per acre (equivalent to approximately 0.24 lbs. actual Cythion per acre of marsh, swamp, woodland, grass and foliage). Most successful fogging is done after sunset in the evening when the earth drops to a temperature less than that of the overlying air. This results in the fog hugging the ground and drifting widely through grass and foliage. Use prevailing wind direction to plan fogging operation. Start at farthest point down-wind and work into the wind at cross angle. If wind becomes strong enough to rapidly dissipate fog, discontinue operation until wind settles.
