DIRECTIONS

This insecticide formulation should not be diluted but used "as is," in Dyna-Fog Insecticide Applicators, or other thermal aerosol fogging machine.

Mosquitoes and Gnats Envelop total area to be treated with a fog around stagnant ponds, swamps and marshlands where mosquitoes breed and adults are easily contacted. (The larvae should be treated with a larvicide.) Do not use this product as a larvicide.

CAUTION:

Do not apply this oil base to valuable ornamental plants as injury may occur.

Flies: Envelop a fine fog. Use fog in killing flies for many critical areas such as rubbish piles, etc. Do not use in dairy barns or on livestock intended for slaughter. Animals should be removed from buildings that are to be fogged; and the fogging should be done by pest control operators. Fogging for mosquito control is only one phase of effective mosquito control. Larvicide applications should be made where standing water cannot be drained.

Most successful fogging is done after sunset, in the evening, when the earth drops to a temperature less than that of the overlying air. This results in the fog hugging the ground and drifting widely through grass and foliage. Use prevailing wind direction to plan fogging operation. Start at farthest point down-wind, and work into the wind at cross angle. If wind becomes strong enough to rupidly dissipate fog, discontinue operation until wind settles.
