DIRECTIONS

To repel horn flies and face flies with the Tox-O-Wik Applicator and the Tox-O-Wik Face Fly Applicator. Dilute one gallon of this product with four gallons of kerosene before placing it in the applicator reservoir. It will take a few minutes for the canvas parts to become saturated. The applicators should be located where the livestock loaf or congregate so that they may have access to it at all times. Repeated applications will build up repellency in those areas of the animal treated with the insecticide repellent.
