

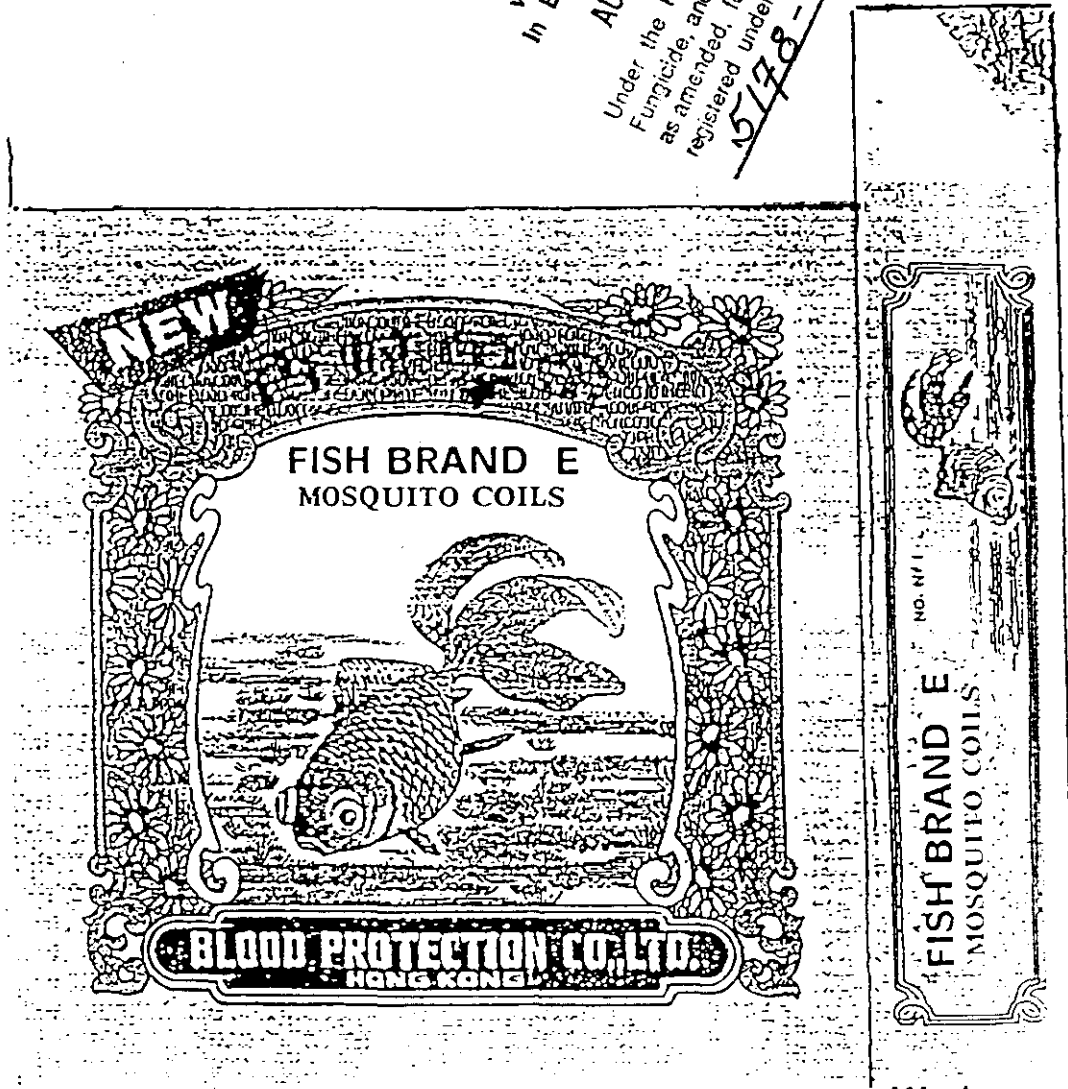
1. Add the phrase "EPA Registration No. 5178-4" to the product label.
2. Submit a revised formula statement showing the certified limits for the active ingredient and supporting the label ingredient declaration of 0.2% d/l-allethrolone d-trans chrysanthemate (or revise the label to declare 0.13%).
3. Have your supplier submit directly to us the composition statements for Tabu powder.

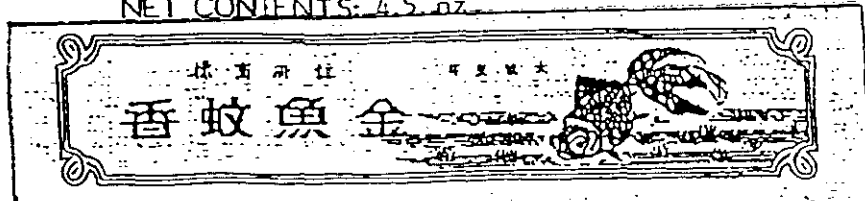

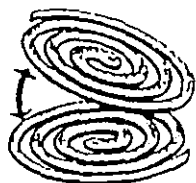

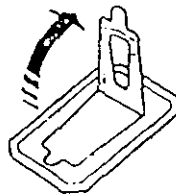

**DIRECTIONS FOR USE**

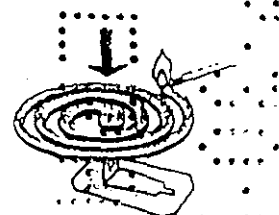
For best results—place one coil about every 8-10 feet around perimeter of area to be protected. Most effective in semi-confined outdoor sites such as porches or patios. Results and duration are affected by airflow and breeze. Save the stands for use with additional coils.



Gently flex and separate interlocked coils.



Bend tab straight up.



Insert tab firmly into coil slot, ignite coil then blow out flame.
