Ensure all pool equipment is working properly. Backwash the filter system following manufacturer's directions. Adjust pH to between 7.2-7.6. Twelve to twenty-four hours after chemical treatment, turn pump on and vacuum dead algae through the filter. Brush any remaining algae and clean backwash filter. If algae is still visible, repeat treatment.
