Bio-Guard Algae All 10 is used to control the growth of algae in swimming pools, exterior spas, whirlpools, and hot tubs. For maximum effectiveness pools, spas, whirlpools, and hot tubs containing heavy growth of algae should be cleaned prior to using Bio-Guard Aigae Ali 10.

For pools having just visible algae growth add an initial dose of 75 to 116 fluid ounces of Bio-Guard Algae All 10 per 10,000 gallons of water and remove settled algae debris by cleaning. For treatment of a freshly cleaned and filled pool add initially 41 to 75 fluid ounces of Bio-Guard Algae Ali 10 per 10,000 gallons of water. Subsequent additions of 13.6 to 27 fluid ounces of Bio-Guard Algae All 10 per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, or hot tubs having just visible algae growth require an initial dose of 8 to 12 fluid ounces of Bio-Guard Algae All 10 per 1000 gallons of water. For treatment of a freshly cleaned and filled spa, whirlpool, or hot tub, add initially 4 to 8 fluid ounces of Bio-Guard Algae All 10 per 1,000 gallons of water. Subsequent additions of 1 to 3 fluid ounces of Bio-Guard Algae All 10 should be made every 5 to 7 days after initial treatment to:

Bio-Guard Algae All 10 is compatible with those chemicals normally used to treat pools and spas and is effective at both acid and alkaline pH. Bio-Guard Algae All 10 can be used in pools and spas treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix Bio-Guard Algae All 10 with concentrated dry or liquid chlorine products.
