Subsequent additions of 14-27 oz. of this product per 10,000 gallons of water should be made every 5-7 days after initial treatment for maintenance.

FOR SPAS:

Spas containing heavy growth of algae should be cleaned prior to using this product. Spas, whirlpools, or hot tubs having just visible algae growth require an initial dose of 8-12 oz. of this product per 1000 gallons of water.
