Dear Mr. Jernigan:

The Agency has reviewed your submission submitted in accordance with continuing registration under the Federal Insecticide Fungicide and Rodenticide Act (FIFRA), as amended, and determined the action to be acceptable with the following conditions:

- Rephrase the third marketing claim: "Kills 99.9% of all odor-causing germs in the bowl water" to "Kills 99.9% of all odor-causing bacteria in the bowl water".
- Under Storage and Disposal, correct the spelling of "or" and add "or place in trash collection" after "Offer for recycling, if available."
- Under Hazards to Humans, change "Wash thoroughly with soap and water after handling" to "Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet."

In summary, your request to move the First Aid statement to the back to the small retail package and update the container disposal section is approved.

A stamped copy of the labeling accepted with conditions is enclosed. Submit one copy of your final printed labeling before distributing or selling the product bearing the revised labeling. 
