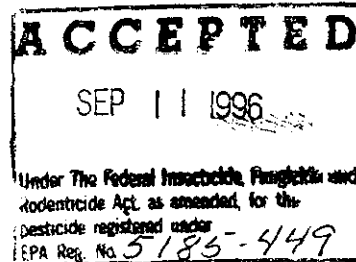

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling. This product may be used for repackaging or formulating as a disinfectant, sanitizer, fungicide, bactericide, algicide and molluscicide. Registration by the Environmental Protection Agency is required before the new product can be lawfully distributed in interstate commerce. This product may be used for non-pesticidal purposes provided no pesticide claims are made.

STORAGE AND DISPOSAL

STORAGE. Keep product dry in tightly closed original container when not in use. Store in a cool, dry, well ventilated area. Product should be stored at 50°F. or above.

DISPOSAL. (Pails/drums) Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. DO NOT REUSE EMPTY CONTAINER.
