

This product may be used for repackaging or formulating as a disinfectant, sanitizer, fungicide, bactericide, algacide and molluscicide. Registration by the US Environmental Protection Agency is required before the new product can be lawfully distributed in interstate commerce. This product may be used for non-pesticidal purposes provided no pesticide claims are made.

STORAGE (Pails, drums, bags) Keep this product dry in original tightly closed container when not in use. Store in a cool, dry, well ventilated area away from heat or open flame. Moisture may decompose this product and cause a violent reaction leading to fire and explosion. In case of decomposition, isolate container if possible and flood area with large amounts of water to dissolve all material before discarding this container. Do not contaminate food or feed by storage or disposal.
