DIRECTIONS FOR USE

SUBTERRANEAN TERMITES: For trench and spot treatments to create chemical barriers dilute 1 to 2 quarts of this product with 50 gallons of water.

Along foundations and around piers dig a narrow trench no deeper than the top of the footings or to a maximum depth of 30 inches. If less than 15 inches deep apply 1 gallon per 5 linear ft. Refill trench, then apply another gallon per 5 linear ft. to the fill. Cover this with a layer of soil. If trench is deeper than 15 inches double the above dosages.

Under attached porches and under similar construction apply dilute mixture to soil surface at the rate of 1 gallon per 10 square ft. Where concrete slabs are to be laid, apply to soil surface at rate of 1 gallon per 10 square feet, but to critical areas, such as along inside of foundation walls, apply at rate of 2 gallons per 5 linear feet by the trench method described above. Spot treatment around sewer pipes, conduits, etc. at 2 gallons per 10 sq. ft.

An annual inspection should be made of all treated areas.

WARNING

Harmful or fatal if swallowed. Avoid breathing spray mist. Contact with the skin can cause toxic symptoms. In case of contact with skin, wash with soap and water. Avoid contamination of feed and foodstuffs. Keep children and pets out of treated areas until spray is dry.
