### DIRECTIONS

**HOUSEHOLD INSECTS**, for control of roaches, ants, spiders, silverfish, crickets, clover mites and earwigs, in and about homes, dairies and food processing plants. Dilute 3 tbs. in 1 quart of water (6½ oz. per gal.). Apply as a coarse spray or paint on window sills, baseboards, drain boards, under sinks and stoves, and other areas frequented by the insects. Repeat as needed.

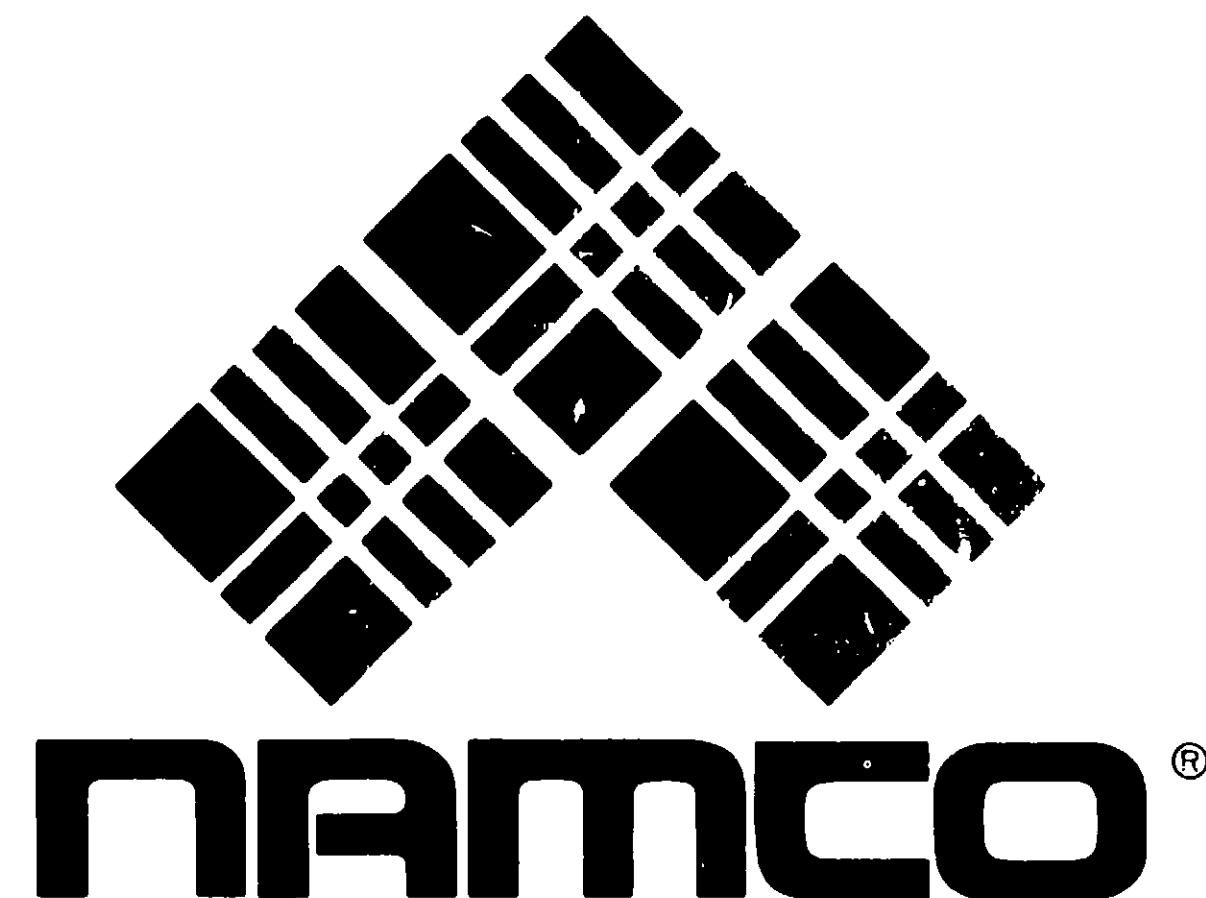

**ORNAMENTAL INSECTS:** On ornamentals such as Azaleas, Camellias, Chrysanthemums, Roses, Stocks, and Evergreens for control of aphids, mealybugs, spider mites, tarnished plant bugs, tent caterpillars, thrips, white flies and wooly aphids, apply at the rate of 1 to 2 teaspoonfuls of concentrate per gallon of water. Spray thoroughly to wet under sides of leaves and repeat as necessary. For scale, apply at 2 teaspoons per gallon and apply when crawlers have settled on foliage.

NOTE: Injury may occur on certain species of ferns, junipers and Crassula

**FLY CONTROL:** For control of flies in and around dwellings, domestic animal structures, outdoor living areas, use a 1% Malathion spray; dilute 2 gallons of NAMCO Malathion-57 to 100 gallons with water (4 tbs. per gal.). Apply as a spray at a rate of 1 gallon per 1000 sq. ft. on painted surfaces; 2 gallons per 1000 sq. ft. on unpainted surfaces where flies alight or congregate, such as ceilings, walls, fences, garbage cans, and shrubbery. 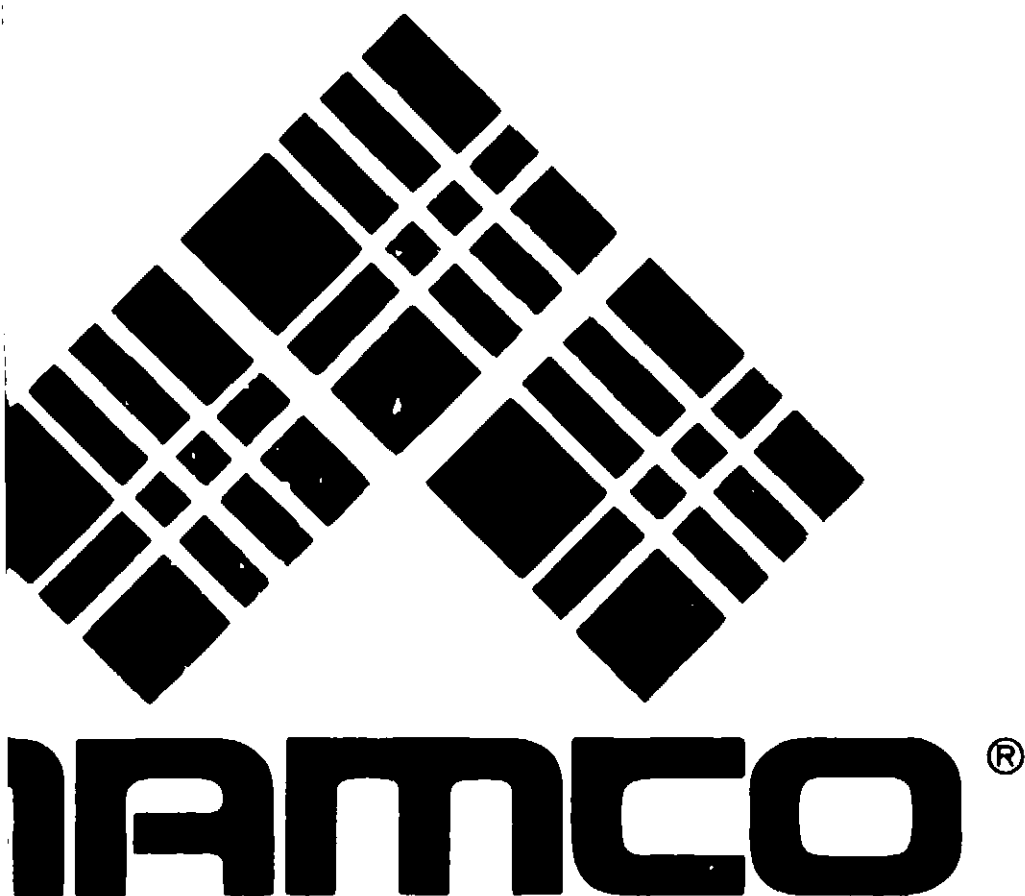

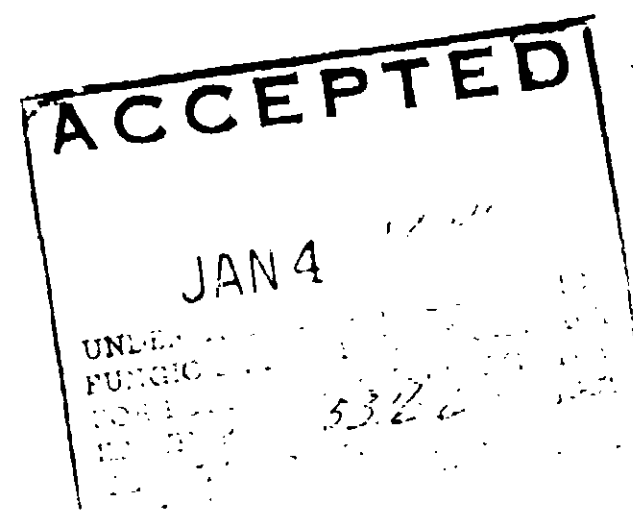

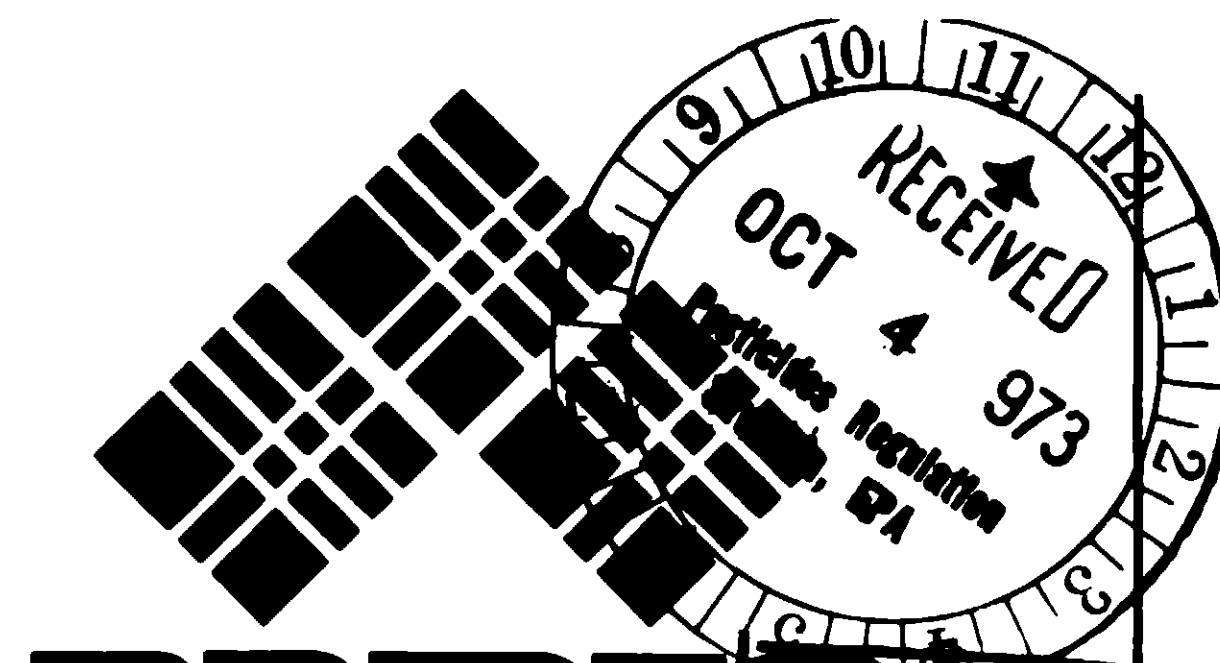
