DIRECTIONS FOR USE

Remove plastic cap. Hold container upright. Point spray opening away from you and press button. Apply sparingly in short bursts.

INDOORS: For house plants, spray in short bursts, holding can 18 inches from foliage of Philodendrom, English ivy and African violets. Spray both sides of the leaves lightly. Do not wet. Repeat as often as necessary. Cover or remove fish bowls for one hour.

When sprayed directly on insects, this spray kills sucking insects — aphids, leafhoppers, spotted mites, thrips (exposed) and lace bugs. Kills chewing insects, climbing cutworms and Japanese beetles. Use a slow sweeping motion. Keep can 18 inches from plants. Avoid wetting foliage with the spray. Spray rows at the rate of one foot per second. For heavy growth, spray row on both sides. Repeat when needed. Spray with caution on young plants and new growth.
