

PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER

Corrosive. Causes irreversible eye damage. Do not get in eyes, on skin, or on clothing. Wear goggles, eye shield or face shield and chemical resistant gloves when handling. Harmful if swallowed or absorbed through skin. May be fatal if inhaled. Avoid breathing vapor or spray mist. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.

FIRST AID

IF IN EYES:	<ul style="list-style-type: none">Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present after 5 minutes, then continue rinsing.Call a poison control center or doctor for treatment advice.
IF ON SKIN OR CLOTHING:	<ul style="list-style-type: none">Take off contaminated clothing.Rinse skin immediately with plenty of water for 15-20 minutes.Call a poison control center or doctor for treatment advice.
IF SWALLOWED:	<ul style="list-style-type: none">Immediately call a poison control center or doctor. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.
IF INHALED:	<ul style="list-style-type: none">Move person to fresh air.If person is not breathing call 911 or an ambulance, then give artificial respiration preferably mouth-to-mouth if possible.Call a poison control center or doctor for further treatment advice.

Have the product container or label with you when calling a poison control center or doctor, or going for treatment.

NOTE TO PHYSICIAN:

Probable mucosal damage may contraindicate the use of gastric lavage.

APPLICATION

Troysan®174P is sold for industrial use only. Troysan®174P is a broad spectrum, non-metallic organic microbiocide designed for use in products subject to bacterial deterioration. Examples of such products are: latex paints, resin emulsions, adhesives (not intended for food contact), pigment dispersions, joint cements, cutting oils, and drilling additives. It is supplied as a powder. Troysan®174P is used in all products where water is a primary component. Normal use levels range from 0.2-0.6% based on the total weight of the formulation. Troysan®174P should be added to the latter phase of the manufacturing process. It should not be exposed to temperatures exceeding 125°F (52°C) for prolonged periods of time. Further, Troysan®174P is not suitable for use in systems with a pH below 3.

NOTE: All amino based products may cause discoloration. Customers are encouraged to check for color stability in their systems.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.
PESTICIDE STORAGE: Do not store near heat or ignition sources. Do not store at freezing temperatures for prolonged periods. This product is corrosive to metal. Do not store in unlined metal containers.
PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticides, spray mixture, or rinsate is a violation of federal law.
