Dear Mr. Swindell:

Please find attached EPA form 8570-1 with OPP Identifier Number 258870. Troy Corporation is submitting changes in labeling requested by EPA in Detroit. The changes include the statement "Made in Canada" and a change in the Manufactured for address. I have highlighted the changes on the first copy of five of each of the labels for Grotan and 2PC.

This notification is consistent with the provisions of PR Notice 95-2 and EPA Regulations at 40CFR 152.46 and no other changes have been made to the labeling or the confidential statement of formula of this product. DIRECTIONS FOR USE

General Classification

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

SOLUBLE EMULSION AND SYNTHETIC CUTTING FLUIDS

2PC should be used at a dilution of 0.15%.

1. For best results, drain and clean the system before adding fresh cutting fluid.
2. Add 0.15% of 2PC to the use dilution. (1.2 pints per 100 gallons of diluted cutting fluid).
3. 0.15% of 2PC should be added to the use dilution of the make-up fluid.

PRECAUTIONARY STATEMENTS:

Hazards to humans and domestic animals. **DANGER:** Corrosive. Causes irreversible eye damage. Do not get in eyes or on clothing. Wear goggles or face shield. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.
