


#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not apply this product in a way that will contact workers or other persons.

The following are suggested use levels for Troysan ALF4. Typical use levels for a particular application indicate the approximate levels for a particular application. These recommendations refer to the percentage by weight of Troysan ALF4, based on the total weight of the end formulation.

Paints and Stains: 0.2 - 1.0%

Wood protective stains use: 0.3 - 1.25%

Adhesives, caulks, grouts and sealants: 0.2 - 0.8%

Stucco and EIFS coatings: 0.1% - 0.8%

Troysan ALF4 is not to be used in formulations intended for food contact paper coatings or food contact adhesive use.

#### STORAGE AND DISPOSAL

STORAGE: Storage temperatures below 90°F (32°C) and above 32°F (0°C) are recommended.

PESTICIDE DISPOSAL: Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law.
