It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Fungitrol 1075 Fungicide is intended only for protecting the applied film of paint, coating, stucco, stain and caulk itself from algal growth. It is **not** intended to protect the substrate to which the preserved material is applied. Products that incorporate Fungitrol 1075 Fungicide in their manufacture may **not** make claims on their labels regarding protection of the substrate from algal growth, without applying for a separate pesticide registration.

An algicide for use in the manufacture of the following aqueous and solvent compositions only: paints, coatings, stucco, stains and caulks to protect the applied paint film, coating, stucco, stain and caulk itself from algal growth. This product may be used at a level ranging from 0.12 to 3% by weight in the final formulated products. The manufactured products are for outdoors uses only, are not to be used in products that may come in contact with water, and are not to be used on wood or any other treated material which is to be used for food, feed, potable water, livestock, dairy animals or living plants.

Important: Read the entire Directions for Use before using this product.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. Store in a dry, cool location.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Non-refillable container. Do not reuse or refill this container. Triple rinse (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then dispose of liner in a sanitary landfill or by incineration if allowed by state and local authorities. If drum is contaminated and cannot be reused, dispose of in the same manner.
