The Antimicrobials Division (AD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The label submitted with the application has been stamped "Notification" and will be placed in our records.

**ENVIRONMENTAL HAZARDS**

This chemical is toxic to terrestrial and aquatic plants, fish and aquatic invertebrates. OMNIPHASE 678 is a dry film **fungicide** and wet state **bactericide** preservative used to prevent the growth of bacteria and fungi in the material **both in the wet state and in the dry film of the** finished product. It is used to preserve the integrity of aqueous systems from deterioration and degradation caused by microorganisms.

Typical use levels given for the various applications indicate the approximate levels for the particular application. All suggested rates are in percentage by weight and refer to the product OMNIPHASE 678. In order to determine the most effective use level for OMNIPHASE 678 in a given use, field trials are suggested.

Interior and Exterior Paints and Stains:	0.5-2.3%
Wood protective stain use:	0.3-1.5%
Caulks, grouts and sealants:	0.3-1.5%
Joint cements:	0.5-1.5%
**Size-Press and other filler/sealant solutions for non-food grade products	0.3-1.0%

OMNIPHASE 678 is not to be used in formulations intended for food contact paper coatings.

**STORAGE AND DISPOSAL**

**PESTICIDE STORAGE:** Storage between 32°F (0°C) and 90°F (32°C) is recommended.

**PESTICIDE DISPOSAL:** Do not contaminate water, food or feed by storage and disposal. Pesticide wastes are acutely hazardous. Improper disposal of excess pesticides, spray mixture, or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by use according to label directions, contact your State pesticide or environmental control agency or the hazardous waste representative at the nearest EPA regional office for guidance. Open dumping is prohibited.

**CONTAINER DISPOSAL:** Nonrefillable container. Do not reuse or refill this container. Clean container promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling or reconditioning if available, or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke. PG09192018
