GENERAL INFORMATION

PRODUCT: The following are suggested use levels for PolyphasePW56. Typical use levels given for the various applications indicate the approximate levels for the particular application. All suggestions are given in percentage by weight and refer to the product PolyphasePW56. **USE:** In order to determine the most cost effective use level in a given use, field trials are suggested.

GENERAL PRECAUTIONS AND RESTRICTIONS

Do not apply this product in a way that will contact workers or other persons. PolyphasePW56 is not to be used in formulations for materials that come into contact with food.

APPLICATION INSTRUCTIONS

PAINTS AND STAINS: Use 0.3-0.9% or 3-9 lb of Polyphase PW56 per one hundred gallons for protection against fungal organisms. For hot, humid areas use up to 1.4% (14 lb). For interior paints use 0.07-0.3% (0.7-3 lb). For wood protective stains use 0.6-0.9% (6-9 lb).

PLASTICS: Use in PVC plastics such as shower curtains, tarpaulins, umbrellas at a level of 0.4-1.8% to prevent surface mildew growth.

WOOD: For above ground use only at rates of 0.4-1.4% depending on protection. For sapstain control, use 0.4% within 24 hours of cutting. For millwork, use 0.4%. Do not apply to wood surfaces that come into contact with food.

TEXTILES: Use 0.07-0.7% for coatings or dyes to prevent fungal growth. **Not for use in fabrics for human wear.**

PAPER COATINGS: For use in non-food contact coatings only

Use in aqueous and solvent-based coatings applied to paper at 0.04-0.5% to prevent surface mold and mildew growth.

CANVAS AND CORDAGE: Use 0.4-1.4% for protection against fungal organisms.

ADHESIVES, CAULKS, GROUTS, SEALANTS: Use 0.04-0.14% to prevent growth of fungal organisms in wet state and in dry film of finished product.

INKS: Use 0.04-2.1% for protection against fungal organisms.

DISPERSED PIGMENTS: For use as a fungicide in the manufacture and storage of dispersed pigments, extender slurries and colorants at 0.2% – 1.5%.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

PESTICIDE STORAGE: This material has a tendency to crystallize at low temperatures. Storage temperatures below 90°F (32° C) and above 32°F (0°C) are suggested.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticides, spray mixture, or rinsate is a violation of federal law. If these

wastes cannot be disposed of by use according to label instructions, contact your State pesticide or environmental control agency or the hazardous waste representative at the nearest EPA regional office for guidance.

CONTAINER HANDLING: Nonrefillable container. Do not reuse or refill this container. Clean container promptly after emptying. Triple rinse as follows: Empty the remaining contents init application equipment or a mix tank. Fill the container ½ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling or reconditioning if available, or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning, if burned, stay out of smoke.
