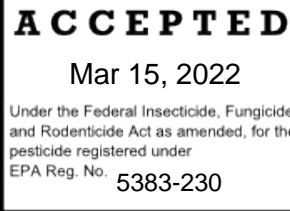
FIRST AID

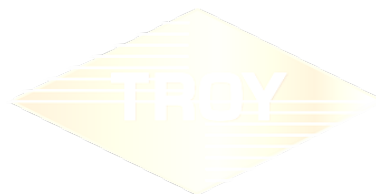

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Do not apply this product in a way that will contact workers or other persons. EX2455 is a water dispersion of biocides effective against a wide variety of fungal and algal organisms. Its primary application is in water-based products where VOC is a major concern. Suggested application levels are based on laboratory and field evaluations and are typical for the use areas indicated. Suggested use levels are reported as percentage weight/weight of EX2455, based on the weight of the final use product.

EX2455 should be added to paints and coatings at the end of the manufacturing cycle, after the final pH adjustment has been made, at the following rate:

Paint	0.45 – 1.2%
Wood protective stains	0.30 – 1.2%
Masonry coatings	0.12 – 0.40%
Roof coatings	0.45 – 1.80%

Only for use in film forming applications where the product is bound by polymer in the film. Avoid spray application and application when rain is imminent. In order to prevent damage to surrounding vegetation cover all exposed vegetation near the application site.

EX2455 may be added to caulks and sealants at the end of the production cycle with good agitation at 0.3-0.9%.

EX2455 may be added to stucco at a rate of 0.5-0.9% and to joint cements at a rate of 0.03-0.75%.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

PESTICIDE STORAGE: Do not store below 44.6°F (7° C). The container should be tightly closed and stored in an upright position.
