SHAKE BEFORE USING/CLOSE CAP AFTER USING/KEEP FROM FREEZING

CLEANING

- 1. Apply to surface directly, or with a damp cloth or sponge.
- 2. Rub surface thoroughly
- 3. Rinse with water.

NOTE: May scratch fiberglass, plastic and other soft surfaces. Test first and rub gently.

DISINFECTING TOILETS AND URINALS

- 1. Flush first to remove any loose soil and residual water.
- 2. Apply SPIRIT to bowl surface, under and around rim of bowl. Spread with toilet bowl brush to cover onere
- 3. Let stand for 10 minutes and flush. (Use a wet cloth, sponge or spray to rinse surfaces that cannot be flushed.)

OTHER SURFACES

- 1. Rinse or wipe off loose soil.
- 2. Apply SPIRIT to surface directly or with damp cloth or sponge, covering surface throroughly.
- 3. Let stand for 10 minutes and rinse.
