In air-washing systems, add 3.5 to 6 fl. oz. of Wrico VRB per 1000 gal. of water to water-collection trays. Repeat treatments every 1-5 days, or as needed. The required frequency depends on relative amount of bleed and severity of slime problem.

Wrico VRB is used to control sulfate-reducing bacteria in petroleum secondary recovery waterflooding operations at dosages of 0.83 to 1.66 fl. oz — f Wrico VRB per 1000 gal. of water treated.
