## FOR SPOT APPLICATION ONLY **DIRECTIONS FOR USE**

For control of Confused Flour Beetle, Flat Grain Beetle, Sawtooth Grain Beetle, Rice Weevil, Maize Weevil, Granary Weevil, Indian Meal Moth, Roaches, Black Carpet Beetle and Silverfish.

For residual application, dilute one gallon of concentrate with 7 gallons of water or deodorized spray base. Methoxane Concentrate when diluted as directed is recommended for use in flour mills, grain elevators and similar grain processing plants. Methoxane may be used for residual applications but not as space spray.

DIRECTIONS FOR RESIDUAL APPLICATION: For the control of insects listed above, dilute according to directions and apply as a coarse spray at the rate of 1 gallon to each 400 to 1800 square feet, depending, on the surface to be treated. Usually heavier applications are required for unnainted wood, concrete, and rough surfaces. Apply behind processing machinery, and to walls, floors, windows, doors and all areas where insects congregate or hide and to their breeding places. Pay particular attention to cracks and crevices from which insects may hide.

Go not use in edible products areas of food processing plants or other areas where food is commercially prepared or processed.

Do not reuse empty Container. Destroy it by perforating or crushing. Bury or discard in a safe place away from water supplies. Do not reuse empty Drum. Return to drum reconditioner or destroy by perforating or crushing and burying in a safe place away from water supplies.
