DIRECTIONS FOR INDUSTRIAL AND INSTITUTIONAL USE

Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using the product in these areas, apply only when the facility is not in operation.

SPACE SPRAYING: Remove pets, birds and cover fish aquariums before spraying. Atomize one ounce per 1000 cubic feet of space to kill flying insects. Kills only exposed insects. For crawling stored grain insects, atomize two ounces per 1000 cubic feet of space. Keep premises closed for at least 10 minutes after fogging.

CONTACT SPRAYING. For Confused Flour Beetle, Flat Grain Beetle, Indian Meal Moth, Granary Weevil, Rice Weevil, Maize Weevil and Saw-Toothed Grain Beetle spray with a hand sprayer or compressed air gun after cleaning out all farinaceous materials from bins, spouls, elevator boots and machinery. Direct spray into all cracks and hiding places to kill accessible stages of insects. For control of Ants, Roaches, Spiders and Crickets spray thoroughly all areas where these insects have been observed and spray directly on the insects wherever possible. Repeat treatment as required

Avoid contamination of feed and foodstuffs. Do not use this material on animals or on plant life. Care should be taken when sprayed on fabrics. Cardinal SF-2 Insecticide may cause staining due to presence of dirt or dust on certain fabrics.

When using in an enclosed area, DO NOT REMAIN IN TREATED AREAS, VENTILATE THE AREA AFTER TREATMENT IS COMPLETED.
