This spray possesses rapid knock-down properties, when one gallon of the concentrate is diluted with 6-8 gallons of Deodorized Spray Base, having a flash point of over 155 degrees F, and suitable for use in fogging machines, and applied at the rate of one gallon of the finished spray to approximately 1000 square feet of surface. Avoid contamination of feed and foodstuffs.

When used as directed this material will control the exposed stages of the confused flour beetles, flat grain beetles, dermestids, roaches, saw-toothed grain beetles, granary weevil and Indian meal moth.

When using in an enclosed area, DO NOT REMAIN IN TREATED AREAS. VENTILATE THE AREA AFTER TREATMENT IS COMPLETED.

Mix at the rate of on gallon of concentrate to 6-8 gallons of Deodorized Spray Base. Agitation is desirable before using. Apply liberally and when necessary as a coarse spray to all areas over which insects might crawl. However, this spray should not be applied to ceilings or walls near vessels that are to be used for processing foods, since insects that are partially paralyzed may drop into the product being processed. In food processing plants, particularly flour and cereal plants, the intested stock should be removed from machines, conveyors, and those areas liberally sprayed

Spray insects directly if possible.

Use this product in processing plants only when plant is not in operation. Food should be removed or covered during treatment and all processing surfaces thoroughly cleaned before using.
