## DIRECTIONS FOR USE

This spray possesses rapid knock-down properties, when one gallon of the concentrate is diluted with 6-8 gallons of water of Deodorized Spray Base and applied at the rate of one gallon of the finished spray to approximately 1000 feet of surface. Do not apply the spray directly to food products.

When used as directed this material will control the exposed stages of the confused flour beetles, flat grain beetles, dermestids, roaches and other closely related insects. Use this product as a space spray in processing plants **only** when plant is not in operation. Food, food processing equipment and surfaces should be covered or removed before use of this product. Thoroughly wash all food processing surfaces that may have become contaminated during treatment with soap and water prior to use.

**DIRECTIONS:** Mix with water or Deodorized Spray Base at the rate of one gallon of concentrate to 6-8 gallons of water or Deodorized Spray Base. Agitation is desirable before using. Apply liberally and when necessary as a coarse spray to all areas over which insects might crawl. However, this spray should not be applied to ceilings or walls near vessels that are to be used for processing foods since insects that are partially paralyzed may drop into the product being processed. In food processing plants, particularly flour and cereal plants, the infested stock should be removed from machines, conveyors, etc. and those areas liberally sprayed.
