DIRECTIONS FOR INDUSTRIAL AND INSTITUTIONAL USES

SPACE SPRAYING:

Atomize with Atomizer or Cardinal Electric Sprayer. To kill Flies, Mosquitos and Gnats, atomize one pint of MILL FOGGING SPRAY NO. 3 per 10,000 cubic feet of space.

To kill accessible Cockroaches (Waterbugs), Crickets, Spiders and Centipedes, atomize one quart of MILL FOGGING SPRAY NO. 3 per 10,000 cubic feet of space. Use in conjunction with contact spraying.

Keep doors and windows closed in order to obtain maximum results. Premises should be closed for at least ten minutes after spraying. Do not remain in treated areas. Ventilate the area after treatment is completed.

CONTACT SPRAYING: For Confused Flour Beetles, Red Flour Beetle, Saw-Toothed Grain Beetle, Flat Grain Beetle, Rice Weevil, Granary Weevil, Maize Weevil, Rusty Grain Beetle and Lesser Grain Borer, spray with a Hand Sprayer or Compressed Air Spray Gun. Clean out bins, elevator boots, elevator spouts, and machines of all farinaceous materials. Then spray MILL FOGGING SPRAY NO. 3 on all surfaces, in cracks and hiding places to kill the accessible stages of insects. This procedure should be repeated as often as necessary.

To kill Roaches (Waterbugs), Silverfish and Spiders in premises, direct this spray toward infested areas and directly on the insects. Thorough application should be made by spraying walls, floors, kitchens, room corners and garbage receptacles. Repeat treatment as often as necessary.
