#### DIRECTIONS FOR INDUSTRIAL USE

SPACE SPRAYING: Atomize one ounce per 1000 cubic feet of space to kill flying insects. Kills only exposed House Flies, Mosquitos and Gnats. Keep premises closed for at least 10 minutes after fogging.

CONTACT SPRAYING: For Grain Mites, Roaches, Earwigs, Sowbugs. Spiders and Centipedes, spray with a hand sprayer or compressed air gun directly on listed insects wherever possible, after cleaning out all farinaceous materials from bins, spouts, etc. Direct spray into all cracks and hiding places. Avoid contaminations of foodstuffs. Do not use this material on infested animals or on growing plant life. Use this product as a space spray in processing plants only when plant is not in operation. Food should be removed or covered during treatment and all processing surfaces thoroughly cleaned before re-using. When used in an enclosed area, do not remain in treated areas, and ventilate the area after treatment is completed.
