## TICIDE

Confused Flour Beetle, and Saw-toothed Grain. Beetle. Direct spray into areas of the room free quented by these insects, hitting as many insects as possible. Intested stored dried fruit should be fumigated or treated by other effective methods, using an approved product intended for this purpose. Close room or warehouse and shut off all ventilating systems. Use a spraying device to dispense this product as a fine mist in the air above the trays and shelves. Use a dosage not to exceed ½ gallon of this spray per 50,000 cubic feet of room space. Repeat application at this dosage in any given month. Leave the room clored for one hour. Do not remain in treated areas and ventilate area before re-entry.

Space Spray: Use undiluted to kill the adult and accessible forms of Rice Weevil, Yellow Meal Worm, Cadelle, Confused Flour Beetle, Angoumois Grain Moth, Mediterranean Flour Moth, and Indian Meal Moth in warehouses, storage rooms and similar locations. Direct spray into corners, under pallets. and around stacks of packaged goods, hittin many insects as possible. Infested packaged go should be fumigated or treated by other effective means using an approved product intended for purpose. Close room or warehouse and shut off all ventilating systems. Use a spraying device to dispense this product. Use a dosage of one fluid ounce of this spray per 1,000 cubic feet of room space. Repeat applications as necessary for insect control. Leave the room closed for one hour. Do not remain in treated areas and ventilate before reentry.

Space Spray: Use diluted to kill flies, adult mosquitoes and gnats in open areas. Dilute the concentrate with petroleum distillate at the rate of one part concentrate to two parts oil and mix well in container before each use. Use at a time when the temperature is cool (75 degrees or less) and wind velocity is approximately five MPH. Spray at a dosage rate of 15 ounces per minute, upwind of area to be controlled. If the equipment is truck-mounted, keep the speed to approximately 5 MPH. Repeat applications as required. Treat a swath width of about 300 feet. Treat shrubbery and vegetation

where (nosquitoes 'may rest. Shrubbery and vegetation around stagnant pools, marshy areas, and ponds may 'be' freated. Application of this product to any body of water is prohibited.

Space Spray: For control of flying and crawling insects in establishments operating under the Federal meat, poultry, shell egg grading and egg products inspection programs.

Dilute concentrate with a white mineral oil conforming to regulation 21 CFR 121.2589 (b) or an odorless light petroleum hydrocarbon conforming to 121.1182, at the rate of one part concentrate to two parts oil, and mix well. Do not apply while food processing is underway. Cover or remove any food. Cover equipment that will be in direct contact with food. Using Micro-Gen type equipment adjusted to deliver aerosol droplets (30 microns or less), apply one ounce per 1000 cubic feet of space. Leave room closed for one hour and ventilate before re-entry.

Facilities and equipment must be washed with an effective cleaning compound and rinsed with potable water after spraying.

Space and Contact Spray: Use undiluted to kill roaches, silverfish, waterbugs, earwigs, ants, spiders, Confused Flour Beetles and Spider Beetles in shekered situations. Adjust equipment for wet, coarse soray. Apply spray into all cracks and crevices in woodwork, walls floors, underneath sinks, behind pipes and in all places where these insects shelter. Do not allow spray to contact stored food. Repeat dosage as often as necessary for control. Leave the room closed for one hour. Do not remain in treated areas and ventilate area before reentry.
