This product will be effective against *Pseudomonas aeruginosa* PRO-10 at this level. It is fungicidal against pathogenic fungi (*Trichophyton mentagrophytes*) at the 2 (two) ounce solution. For best results, apply SUPER STAPH-TROLE 64 use solution to walls, ceilings, and floor with a clean mop, cloth or sponge. Thoroughly wet all surfaces. Treated surfaces must remain wet for 10 minutes. Prepare a fresh solution daily or when use solution becomes visibly dirty. 2) Always use with clean equipment. 3) Always wear rubber gloves when using this product. 4) Do not mix with any other products (cleaners, detergents or other chemicals). 5) For heavy soil or organic matter a pre-cleaning step is required. This is, clean twice with a solution of 2 (two) ounces per gallon of water.

**DANGER: CORROSIVE**
