

ALCO L-T STOCK SPRAY is formulated for the control of ticks, hornflies, lice, keds, stableflies and mosquitoes on livestock and also is an effective premise spray for the control of mosquitoes, fleas, stableflies, roaches on such agricultural premises as barns, sheds, animal shelters, fences, other farm buildings. DO NOT USE IN OR AROUND DAIRY BARNS, MILK ROOMS, OR POULTRY HOUSES.

DIRECTIONS FOR USE:

Mix ALCO L-T STOCK SPRAY only as directed under specific usage recommendations. Apply only as specified. Do not treat animals under 3 months of age. Very young animals can be injured by this treatment. Do not apply to dairy cattle or dairy goats.


Do not treat meat animals within 30 days of slaughter.

BEEF CATTLE: TICKS, HORNFLIES, STABLE FLIES (Supplemental control), LICE, MOSQUITOES — Mix one quart in forty gallons of water (5 pints in 100 gallons of water). For control of these pests and protection against reinfestation, spray animals thoroughly, including legs, using two quarts of dilute spray per animal. Repeat as necessary. For lice, one treatment should give season-long control. Do not use on dairy animals.

SHEEP AND GOATS: LICE AND KEDS (Sheep Ticks)—Mix one quart in 120 gallons of water (27 fluid ounces per one hundred gallons of water). Spray animals thoroughly to wet, including legs. Better control will be had if the animals are sprayed after shearing. One application will be normally sufficient for control.

FLEECE WORMS AND TICKS — Mix one quart in 40 gallons of water (5 pints in 100 gallons of water). Spray animals thoroughly to wet, including legs. Repeat as necessary. HOGS: LICE, TICKS — Mix one quart in 40 gallons of water (5 pints in 100 gallons of water). Apply as a thorough spray. For ticks repeat as necessary. One application is usually sufficient to control lice. DO NOT SPRAY SOWS WITHIN 2 WEEKS OF FARROWING NOR FOR AT LEAST 3 WEEKS AFTER.

BACK RUBBERS — OILERS: HORNFLIES, LICE on BEEF CATTLE — Mix one quart in 3 gallons fuel oil, diesel oil or other recommended back rubber oil. Charge backrubber tank or soak burlap oiler until thoroughly wet but not dripping. Recharge as necessary. This treatment will give a rapid reduction of hornflies and act as an aid in reducing infestations of lice on cattle. Do not use crankcase oil or other like oils as they will be harmful to the animals. Do not allow meat animals access to backrubbers or oilers within 30 days of slaughter. Do not apply to animals under 6 months of age. Do not apply to dairy animals.

PREMISE OR AREA SPRAY, AGRICULTURAL PREMISES SUCH AS BARNS, SHEDS, FENCES, ANIMAL SHELTERS, OTHER FARM BUILDINGS (EXCEPT DAIRY BARNS, MILK ROOMS OR POULTRY HOUSES): Fleas, mosquitoes, stableflies, roaches. Mix one pint in five gallons of water. Apply to interior and exterior surfaces where insects alight or crawl. For fleas spray cracks, crevices, base of walls and floors. For roaches, spray cracks, crevices, base of walls in barns and areas where seen running. Apply spray to point of runoff. In animal quarters, treat bedding areas as well as ground areas adjacent for improved flea control. Do not treat animals with this dilution. Do not apply in dwellings. Repeat treatment as necessary. Remove or protect all feed and water during spraying operations.
