Avoid contact with eyes or clothing. Avoid breathing dust. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.

When judiciously applied into the cracks and crevices which traditionally harbor cockroaches it will afford extended protection (if left undisturbed) against this universally unaccepted insect, ALCO Sta-Gon! INSECTICIDAL DUST acts slowly but continuously and when properly applied should kill the roach population within 7 to 10 days. Furthermore, because it is non-volatile, it will remain active and effective for extended periods of time if left undisturbed. undisturbed.

#### COMMERCIAL USE

Use power duster to apply to large voids such as beneath manholes at the rate of 1 to 2 pounds per manhole opening. One application is usually sufficient for extended periods of time providing dust is not washed away.

#### **FLEA CONTROL INDOORS**

PRIOR TO APPLICATION: If carpet or flooring (wood or other non carpeted) needs to be cleaned, do so before application. Carpets must be completely dry. All carpeted closet floors should be cleared. Electronic equipment, fish tanks, and animal cages must be covered or removed. Children and pets should be removed from treatment area until application is complete. Use approximately 2.5 lbs. per 1.000 sq.ft. of carpeted area. Quantities will vary depending on carpet type.

#### FLEAS IN RUGS AND CARPETING

Apply to dry surfaces only directly to rugs and carpets where pets frequently traffic or sleep. Sprinkle lightly over all the area, including closets, area rugs, under beds and areas frequented by pets. Work powder deep into libers and mat with a broom or rug rake until it is no longer visible. Any visible product remaining after application must be removed by further brooming or with the use of a vacuum.

#### FLEAS IN PET RESTING/SLEEPING QUARTERS

Sprinkle the powder over wood flooring around and beneath pet sleeping quarters. Brush and work the powder into cracks and crevices for residual flea control. Remove any excess surface powder with a damp sponge or mop, Retreat as needed.
