

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS
(& DOMESTIC ANIMALS)

DO NOT TAKE INTERNALLY
DO NOT GET IN EYES

CAUTION: May be harmful if swallowed, inhaled or absorbed through skin. Do not breathe dusts, get in eyes, on skin or on clothing. Wash thoroughly with soap and warm water after handling. STORAGE AND DISPOSAL

STATEMENT OF PRACTICAL TREATMENT

If Swallowed: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.

If on Skin: Wash with soap and warm water.

If in Eyes: Flush with flowing water.

USE PRECAUTIONS

Read entire label before using: Use only on crops and for purposes recommended on this label. Do not allow to drift to adjoining crops. The grower is responsible for residues on his crops, as well as for damages caused by drift from his property to that of others. In order that pesticidal residues on food and forage crops will not exceed tolerances established by the Federal Food and Drug Administration, use only at recommended rates and intervals, and do not apply closer to harvest than specified. Do not allow to drift to areas occupied by unprotected humans or beneficial animals or onto adjoining food, fiber or pasture crops. Durham Metaldehyde Granules is a product specially formulated for the control of snails and slugs. It is a uniform free-flowing product which facilitates easy application through any cyclone type hand seeder. NOTE: Durham Metaldehyde Granules should never be applied to dry soil. Application should be made following an irrigation for best results. Application can be made any time of the day but evening applications are preferred. Do not re-water for 48 hours after application.

DIRECTION FOR USE:

ORNAMENTALS AND TURF: Broadcast lightly to spread the material upon lawn or ornamental garden area. Water lawn and ornamental garden thoroughly before applying material.

FOR DICHONDRA AND TURF LAWNS: For the control of snails and slugs, water infested area thoroughly, broadcast DURHAM METALDEHYDE GRANULES 3.5 directly on lawn or turf. One pound will cover 1500 square feet. Do not re-water for 48 hours.

FOR ORNAMENTAL GARDENS, PLANTED BORDERS, AND GROUND COVER: For the control of snails and slugs, water infested area thoroughly, broadcast or sprinkle DURHAM METALDEHYDE GRANULES 3.5 over infested areas and along edges of flower beds adjacent to border or ground cover plants. Also apply on ground at base of fences and walls in shady, protected locations.

CITRUS (ORANGES, LEMONS, GRAPEFRUIT): Broadcast liberally under trees, (CAUTION: DO NOT GET ON FOLIAGE OR FRUIT), around irrigation pipes, buildings and any other place slugs and snails may congregate. Apply at the rate of 40 pounds per acre.
