Do not allow bait granules to come in contact with parts of plant that may be used for food or feed purposes. The grower is responsible for residues on his crops, as well as for damages caused by drift from his property to that of others. Do not allow drift to adjoining food, fiber or pasture crops. NOTE: DURHAM METALDEHYDE GRANULES 3.5 should never be applied to dry soil. Applications should be made following irrigation for best results. Apply any time of the day but evening applications are preferred. Do not re-water for 48 hours after application.

GENERAL INFORMATION

Snails and slugs are nocturnal and generally feed during the night damaging many varieties of plants and plant seedlings. They inhabit damp, moist areas around decaying refuse, organic matter, beneath boards, rocks and trash piles and hide at the base of growing plants. Their presence can be detected by the shiny trails left on the soil surface, sidewalks, driveways, etc.

APPLICATION RATES

For control of SNAILS and SLUGS in the following areas, use one pound to treat 1,100 to 1,500 sq. ft. of soil surface equivalent to 30 to 40 pounds of granules per acre, unless otherwise noted below. Apply when first plant damage appears or is anticipated and repeat as needed for control.

FIELD CROPS

Cereal Grains (Barley, Oats, Wheat), Corn, Legumes (Alfalfa, Beans, Clover, Cowpeas, Peas), Mint: Band application over seed line at planting or slightly later. Repeat applications may be made if needed. Apply up to 20 pounds per acre. Total pounds of formulation applied must not exceed 86 pounds (3 pounds a.i.) per acre per growing season.

DICHONDRA AND/OR TURFGRASS LAWNS

Water infested area thoroughly before application. Broadcast DURHAM METALDEHYDE GRANULES 3.5 directly on lawn or turf. Spread evenly. One pound will cover up to 1,500 sq. ft. Do not re-water for 48 hours.

ORNAMENTAL PLANTS

ORNAMENTAL GARDENS, PLANTED BORDERS AND GROUND COVERS: Including Azaleas, Begonias, Camellias, Chrysanthemums, Daffodils, Daisies, Geraniums, Honeysuckle, Hydrangeas, Ice Plant, Impatiens, Iris, Marigolds, Pansies, Petunias, Rhododendron, Roses, Sweet Peas, Snapdragons, Spathiphyllum, Tulips. Water the infested area thoroughly before application. Broadcast or sprinkle DURHAM METALDEHYDE GRANULES 3.5 evenly over the infested areas and along edges of flowerbeds adjacent to border or ground cover plants. Also apply on ground at base of fences and walls in shady, protected locations. One pound will cover up to 1,100 sq. ft. Do not re-water for 48 hours.

ORNAMENTAL GREENHOUSES

Water or irrigate greenhouse soil to be treated before application. Broadcast DURHAM METALDEHYDE GRANULES 3.5 liberally around greenhouse, under benches in greenhouse and around plants; any place where SNAILS and SLUGS might congregate. Do not apply directly to plants unless prior experience has shown the plant to be tolerant to this product. Most plants are tolerant to DURHAM METALDEHYDE GRANULES 3.5. However, some slight tip burning has been noticed on extremely tender orchids. One pound will cover up to 1,100 sq. ft. Do not re-water for 48 hours. NOTE: This product has proven to have a reasonable residual control. However, for heavily infested greenhouses, a second application is recommended 7 to 10 days following the first application to bring the house under control.

SEED CROPS

Legumes (Alfalfa, Beans, Clover, Peas): Apply up to 20 pounds per acre. Total pounds of formulation applied must not exceed 86 pounds (3 pounds a.i.) per acre per growing season.

Beets, Cabbage, Carrots, Collards, Flowers, Grasses, Kale, Kohlrabi, Mustard, Radish, Sugar Beets, Turnips: Apply up to 40 pounds per acre. Total pounds of formulation applied must not exceed 129 pounds (4.5 pounds a.i.) per acre per growing season.

Cauliflower, Lettuce, Spinach, Swiss Chard, Tobacco: Apply up to 40 pounds per acre. Total pounds of formulation upplied must not exceed 86 pounds (3 pounds a.i.) per acre per growing season.

SMALL FRUITS AND BERRIES

Strawberries: Band application in borders and around perimeter of crop. Apply up to 40 pounds per acre. Total pounds of formulation applied must not exceed 129 pounds (4.5 pounds a.i.) per acre per growing season.

Grapes: Band application between rows. Apply up to 40 pounds per acre. Total pounds of formulation applied must not exceed 129 pounds (4.5 pounds a.i.) per acre per growing season.

Blackberries, Blueberries, Cranberries, Loganberries, Raspberries: Apply up to 40 pounds per acre. Total pounds of formulation applied must not exceed 86 pounds (3 pounds a.i.) per acre per growing season.

TREE CROPS

Apples, Apricots, Avocados, Cherries, Peaches, Pears: Apply up to 40 pounds per acre. Total pounds of formulation applied must not exceed 86 pounds (3 pounds a.i.) per acre per year.

VEGETABLE CROPS AND GARDENS

Beets, Broccoli, Brussels Sprouts, Cabbage, Cauliflower, Garlic, Ginseng, Horseradish, Kale, Kohlrabi, Leeks, Mustard Greens, Onions, Parsnips, Potatoes, Radishes, Rutabagas, Salsify, Shallots, Sweet Potatoes, Turnips: Apply up to 40 pounds per acre. Total pounds of formulation applied must not exceed 129 pounds (4.5 pounds a.i.) per acre per growing season.

Asparagus, Beans, Black-eyed Peas, Cantaloupe, Cucumbers, Eggplant, Endive, Lettuce, Melons, Okra, Peas, Peppers, Pimentos, Pumpkins, Rhubarb, Spinach, Squash, Swiss Chard, Tomatoes, Watermelons: Apply up to 40 pounds per acre.
