## PRECAUTIONARY STATEMENTS

### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

**WARNING:** May be fatal if swallowed. Do not take internally. Harmful dust. Avoid breathing dust or vapor. Avoid contact with skin, eyes, and clothing. Do not contaminate food or feed. Wash thoroughly after handling and before eating. Keep children and pets out of treated area.

**Statement of Practical Treatment:** If swallowed, administer warm water freely and induce vomiting by use of an emetic or by sticking finger down throat. Repeat until professional medical assistance has been secured. If on skin, wash skin immediately with plenty of soap and water. If in eyes, rinse eyes with plenty of water for at least 15 minutes. Get medical attention if irritation persists. If inhaled, remove affected person to fresh air. Seek medical attention if symptoms of poisoning are present.

## DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Read entire label before using.

Subsequent planting of food and feed crops in treated soil must be made with crops on this or other carbaryl labels.

Water area to be treated thoroughly prior to applications, then withhold water for 48 hours after application.

Can be applied any time during the day, but late afternoon or evening is recommended. Apply by simply shaking the proper amount of material from the convenient shaker can.

For the control of SNAILS and SLUGS on ornamental gardens, planted borders, ground covers, dichondra lawns and turf lawns, use at the rate of 1 lb. to 1500 sq. ft. of area.

Apply over the infested area, around the edges of borders or ground cover plants, around the bases of fences and walls and in shady protected areas. Repeat treatment as necessary.

For the control of ANTS, EARWIGS, FALL ARMYWORMS, SOD WEBWORMS (LAWN MOTHS) and SOWBUGS on ornamental gardens, planted borders, ground covers, dichondra lawns and turf lawns, use at the rate of 1 lb. to 250 sq. ft. of area. Apply as indicated above. Repeat as necessary.

## STORAGE AND DISPOSAL

**STORAGE:** Keep out of reach of children. Do not store in direct sunlight.

**DISPOSAL:** Do not reuse empty container. Wrap container and put in trash collection.
