Water area to be treated well, prior to application. Withhold rewatering treated area for 48 hours. This product can be applied anytime during the day, but late afternoon or evening applications are preferred.

DIRECTIONS FOR USE

CITRUS (Oranges, Lemons and Grapefruit): For the control of slugs and snails apply at the rate of 30 to 50 pounds per acre through any cyclone type hand seeder or mechanical ground applicators that gives even distribution of granules. Broadcast Durham Sevin Metaldehyde Granules 5-2.5 liberally under trees around irrigation pipes, farm buildings and any other place slugs and snails may congregate.

CAUTION: Do not apply to tree foliage or edible parts.

Durham Sevin Metalydehyde Granules 5-2.5 should never be applied to a dry soil. It is suggested that the application be made following an irrigation.

ORNAMENTAL GARDENS, PLANTED BORDERS, AND GROUND COVERS: For the control of snails, slugs, cutworms, armyworms, sowbugs, dark ground beetles, and crickets apply at the rate of 30 to 50 pounds per acre (one pound will cover 1000 to 1500 square feet) through any cyclone type hand or mechanical seeder that gives even distribution of the granules. Water area to be treated well, prior to application. This product can be used any time during the day, but late afternoon or evening application is preferred. Do not water treated area for 48 hours after application.

DICHONDRA AND TURF LAWNS: For the control of snails and slugs apply at the rate of 30 to 50 pounds per acre (one pound will cover 1000 to 1500 square feet) through a cyclone type hand or mechanical seeder that gives even distribution of the granules. For the control of ants, earwigs, fall armyworms, sod webworms (lawn moths) and sow bugs apply 4 pounds of this material per 1000 square feet in the same manner as described above. Water area to be treated well, prior to application. This product can be used any time during the day, but late afternoon or evening application is preferred. Do not water treated area for 48 hours after application.
