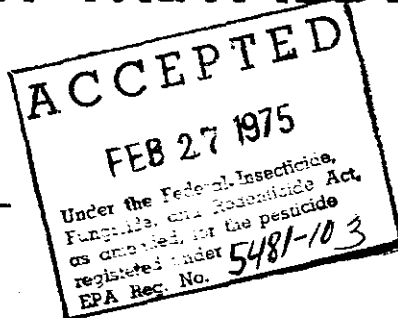

DURHAM METALDEHYDE GRANULES IS A PRODUCT SPECIALLY FORMULATED FOR THE CONTROL OF SNAILS AND SLUGS. IT IS A UNIFORM FREE-FLOWING PRODUCT WHICH FACILITATES EASY APPLICATION THROUGH ANY CYCLONE TYPE HAND SEEDER. NOTE: DURHAM METALDEHYDE

GRANULES SHOULD NEVER BE APPLIED TO DRY SOIL. APPLICATION SHOULD BE MADE FOLLOWING AN IRRIGATION FOR BEST RESULTS. APPLICATION CAN BE MADE ANY TIME OF THE DAY BUT EVENING APPLICATIONS ARE PREFERRED. DO NOT RE-WATER FOR 48 HOURS AFTER APPLICATION.

DIRECTIONS FOR USE:

CITRUS (ORANGES, LEMONS, GRAPEFRUIT): BROADCAST LIBERALLY UNDER TREES, (CAUTION: DO NOT GET ON FOLIAGE OR FRUIT), AROUND IRRIGATION PIPES, FARM BUILDINGS AND ANY OTHER PLACE SLUGS AND SNAILS MAY CONGREGATE. DO NOT EXCEED 20 POUNDS OF THIS PRODUCT PER ACRE.

ORNAMENTAL GARDENS, PLANTED BORDERS AND GROUND COVERS: WATER INFESTED AREA THOROUGHLY BEFORE APPLICATION. BROADCAST OR SPRINKLE DURHAM METALDEHYDE GRANULES EVENLY OVER INFESTED AREAS AND ALONG EDGES OF FLOWER BEDS ADJACENT TO BORDER OR GROUND COVER PLANTS. ALSO APPLY ON GROUND AT BASE OF FENCES AND WALLS IN SHADY, PROTECTED LOCATIONS. ONE POUND WILL COVER UP TO 2500 SQUARE FEET. DO NOT RE-WATER FOR 48 HOURS.

DICHONDRA OR TURF LAWNS: WATER INFESTED AREA THOROUGHLY BEFORE APPLICATION. BROADCAST DURHAM METALDEHYDE GRANULES LIGHTLY TO SPREAD THE MATERIAL EVENLY DIRECTLY ON DICHONDRA OR TURF. ONE POUND WILL COVER UP TO 2500 SQUARE FEET. DO NOT RE-WATER FOR 48 HOURS.

ORNAMENTAL GREENHOUSES: WATER OR IRRIGATE GREENHOUSE TO BE TREATED BEFORE APPLICATION. BROADCAST DURHAM METALDEHYDE GRANULES LIBERALLY AROUND GREENHOUSE, UNDER BENCHES IN GREENHOUSES AND AROUND PLANTS; ANY PLACE WHERE SNAILS AND SLUGS MIGHT CONGREGATE. DO NOT APPLY DIRECTLY TO PLANTS UNLESS PRIOR EXPERIENCE HAS SHOWN THE PLANT TO BE TOLERANT TO THIS PRODUCT. MOST PLANTS ARE TOLERANT TO DURHAM METALDEHYDE GRANULES 7.5 HOWEVER SOME SLIGHT TIP BURNING HAS BEEN NOTICED ON EXTREMELY TENDER ORCHIDS. ONE POUND WILL COVER UP TO 2500 SQUARE FEET. DO NOT RE-WATER FOR 48 HOURS. NOTE: DURHAM METALDEHYDE GRANULES 7.5 HAS PROVEN TO HAVE A REASONABLE RESIDUAL CONTROL, HOWEVER FOR HEAVILY INFESTED GREENHOUSES A SECOND APPLICATION IS RECOMMENDED 7 TO 10 DAYS FOLLOWING THE FIRST APPLICATION TO BRING THE HOUSE UNDER CONTROL.
