Do not re water for 48 hours after application

# DIRECTIONS FOR USE: (Cont.)

CITRUS (ORANGES, LEMONS, GRAPEFRUIT): Broadcast liberally under trees, (CAUTION: DO NOT GET ON FOLIAGE OR FRUIT), around irrigation pipes, farm buildings and any other place slugs and snails may congregate. Do not exceed 20 pounds of this product per acre

ORNAMENTAL GARDENS, PLANTED BORDERS AND GROUND COVERS: Water inlested area thoroughly before application. Broadcast or sprinkle Durham Metaldehyde Granules evenly over infested areas and along edges of flower beds adjacent to berder or ground cover plants. Also apply on ground at base of fences and walk in shady, protected locations. One pound will cover up to 2500 square feet Do notere-water for 48 hours.

**DICHONDRA OR TURF LAWNS:** Water infested area thoroughly before application. Broadcast Durham Metaldehyde Granules lightly to spread the material evenly directly on dichondra or turf. One pound will cover up to 2500 square feet. Do not re-water for 48 hours

ORNAMENTAL GREEDHOUSES: Water or irrigate greenhouse to be treated before application. Broadcast Durham Metaldehyde Granules liberally around greenhouse, under benches in greenhouses and around plants, any place where snails and slugt might congregate. Do not apply directly to plants unless prior experience has shown the plant to be tolerant to this product. Most plants are tolerant to Durham Metaldehyde Granules 7.5 however some slight tip burning has been noticed on extremely tender orchids. One pound wiff cover up to 2500 square feet. Do not re-water for 48 hours. NOTE: Durham Metaldehyde Granules 7.5 has proven to have a reasonable residual control, however for heavily intested greenhouses a second application is recommended 7 to 10 days following the first application to bring the house under control
