DIRECTIONS FOR USE:

**FOR USE AROUND HOMES, APARTMENT BUILDINGS, AND OFFICE BUILDINGS.
FOR OUTDOOR USE ONLY—**

- ANTS:** Apply directly to anthill. Around buildings and along runways. Repeat as necessary. Do not apply where food crops are growing.
- EARWIGS:** Dust around fences, rubbish piles and other areas where insects may hide. Do not apply where food crops are growing.
- SPIDERS & CENTIPEDES:** Thoroughly dust infested areas (baseboards, corners, pipes, storage localities), and repeat when necessary.

LAWNS AND TURF

JAPANESE BEETLE GRUBS, WHITE GRUBS, CHAFER BEETLE GRUBS: Apply 1 pound to 700 square feet. Water thoroughly after application.

LAWN MOTHS, ANTS, TICKS, CHIGGERS, SOD WEBWORMS, CUTWORMS, ARMYWORMS, CRICKETS, MOLE CRICKETS, EARWIGS: Apply 1 pound to 700 square feet. Sprinkle lightly after application.

NOTE: Birds feeding over treated lawn may be harmed.

FLOWERS AND ORNAMENTALS

ANTS, THrips, SOWBUGS, LEAF MINERS, LEAF ROLLERS, LYGUS BUGS: Dust or spray upper and lower leaf surfaces in early morning or evening when air is still. Repeat as necessary.

ARMYWORMS, CRICKETS, MOLE CRICKETS: Apply 1 pound per 700 square feet. Apply to soil around base of plants and along rows.

EARWIGS: Use same amount, applying to soil around base of plants and along rows; in damp shady areas, around and under rocks, boards and similar places.

JAPANESE BEETLE GRUBS: Apply 1 pound per 250 square feet. Work into top four inches of soil around base of plants. **CUTWORMS, STRAWBERRY ROOT WEEVIL (BRACHYRHINUS):** Dust or spray generously around base of plants, working into top four inches of soil. Repeat as necessary. See Caution.

CAUTION: Avoid inhalation. Avoid skin contact. In case of contact with skin, wash with soap and water. Wash hands after use. Avoid contamination of feed and foodstuffs. Keep out of reach of children. Keep children and pets off treated lawns until dust is washed into soil and the treated lawns have dried completely. Do not contaminate drinking water or use near fish ponds, etc. Do not apply on plants in bloom, as chlordane is toxic to pollinizing insects. Do not apply to any food or feed crop.

This product is toxic to fish, birds and other wildlife. Birds and other wildlife in treated areas may be killed. Keep out of lakes, streams or ponds. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.

ANTIDOTE:

EXTERNAL—In case of spillage on skin, wash promptly with soap and water.

INTERNAL—Emetic of 1 tablespoon of mustard in tumbler of water. Call a physician.

Rinse equipment and containers and dispose of wastes by burying in non-crop lands away from water supplies. Containers should be disposed of by punching holes in them and burying with wastes or by burning. Keep out of smoke.
