# RONNEL GRANULES 5

Controls Hog Lice on all ages of swine—newborn, too. Also controls housefly maggots (larvae), and chicken body lice on poultry.

Ronnel [0,0-Dimethyl 0-(2,4,5-trichlorophenyl) phosphorothioate\*] 5%

**DIRECTIONS FOR USE**

Distribute with a mechanical spreader, scoop, or can.

**Control of Hog Lice:** Apply evenly over the bedding for swine at the rate of ½ pound per 100 square feet of area.

No mixing with the bedding is necessary. One treatment will control the hog lice infestation when the animals use the bedding regularly. Retreat if reinfestation occurs.

**Control of Chicken Body Lice on Poultry:** Scatter evenly over the litter at the rate of 1 pound per 100 square feet. This product may be used in broiler, layer, and replacement pullet houses. Re-treat if reinfestation occurs.

**Control of House Fly Maggots (larvae): Caged-layer Poultry Houses:** Apply at the rate of 1 pound per 100 square feet of area. Apply evenly over manure pile, under layer cages, and over the cages, and over the floor area where flies breed. Re-treat as needed. If first applied when flies are numerous, it may take 2 weeks or more for a noticeable reduction in number of adult flies.

**USE PRECAUTIONS**

This product is toxic to fish. Do not contaminate water by cleaning of equipment, or disposal of wastes.  
Keep out of lakes, streams, or ponds. Do not apply where runoff is likely to occur. Apply this product only as specified on this label.  
Do not reuse empty container. Dispose of it by burning or burying in noncrop-lands away from water supplies.
